
Gentlemen:

This letter serves as my notice of resignation from my position as Director of Missions of the Tillman Baptist Association. I am resigning my position because I sexually molested [REDACTED] over a period of years during his youth. I do not believe I should continue to serve as Director of Missions. My resignation is in the best interests of the Tillman Baptist Association and me.

I agree, covenant and promise that I will not in the future accept employment or a volunteer position with any organization such as with a church, Big Brothers/Big Sisters, or a school, which would allow me to have contact with children. Similarly, I agree, covenant and promise that I will not in the future form or maintain personal relationships or contacts with children in any community. If I accept such employment or a volunteer position, or if I form or maintain personal relationships or contacts that permit me to have contact with children, I agree that the Tillman Baptist Association may present a copy of this resignation letter to my employer, the volunteer organization, to the appropriate law enforcement authorities, or to the parents or guardians of the children involved.

This resignation is effective immediately this 5th day of September, 1996.

Dear Mr. Wylie:


On September 5, 1996 you were present when Dr. Anthony Jordan laid out a pre-printed letter with a place for my signature, wherein it was written that "I sexually molested [REDACTED] over a period of years during his youth."

I signed that letter under extreme duress, shocked and insulted, and so fearful, that my normal faculties of reason were lost to me.

No one asked me if I had done such a thing. Instead Dr. Jordan said "[REDACTED] has been in our office and says you have molested him, and we believe you are guilty."

Categorically, with God inspired insight and forthrightness I swear to you now that I did not, ever, molest [REDACTED]. It is true that he was molested. But by [REDACTED]. He has had a very difficult life, and apparently still does. Whatever his motivation, what he said about me was not true. [REDACTED]

I have gone to counseling and because of that I have learned much about myself. One thing I have learned is that I should not simply lay down and accept lies for the convenience of others.

Mr. Hayslip has contracted for my services. We demand that the letter he was unlawfully coerced into signing be returned to him immediately with all copies. We demand an apology for the pain and suffering Mr. Hayslip has had to endure. Especially we demand that no one ever again visits a place of his employment with that letter.

Mr. Hayslip has been severely damaged. Mr. Jordan failed to apply even a pretense at a fair hearing. Your own constitution was violated when Dr. Jordan threatened Rev. Hayslip with legal proceedings with your attorney, Rev. Hayslip felt Dr. Jordan was going to have him thrown into jail, and this fear was so consuming that he signed the document ~ without any advice from anyone ~ and no time to get it.
